NOTIFICATION

The Ministry of Personnel, Public Grievance and Pensions, Government of India has extended the benefit of 10% reservation for Economically Weaker Sections (hereinafter referred to as "EWSs") not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Government of India vide office Memorandum No. 36039/1/2019-Estt (Res) dated: 31st January, 2019.

- 1. In pursuance to the aforesaid Office Memorandum, the State Government has decided to identify the Economically Weaker Sections from amongst the people belonging to the other Backward Classes (State list) for availing 10% reservation in direct recruitment in civil posts and services in the Government of India. The persons of the communities belonging to the Other Backward Classes (State list) i.e. i)Newar ii) Bahun iii) Chettri and iv) Majhi has been identified as the eligible persons for 10% reservation in direct recruitment in civil posts and services in the Government of India.
- 2. The eligibility criteria for identification as EWSs for the Communities belonging to the Other Backward Classes (State List) shall be the persons whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only). Income shall also include income from all sources i.e. salary, agriculture, business, profession etc for the financial year prior to the year of application.
- 3. Persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:-
 - (i) 5 acres of agricultural land and above;
 - (ii) Residential flat of 1000 sq.ft and above;
 - (iii) Residential plot of 100 sq. yards and above in notified municipalities;
 - (iv) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- The property held by a "Family "in different locations or different places/ cities
 would be clubbed while applying the land or property holding test to determine
 EWS status.
- The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 (eighteen) years as also his/her spouse and children below the age of 18 (eighteen) years.
- 6. The District Magistrate/ Additional District Magistrate / Sub-Divisional Magistrate shall be the issuing authority to issue the Certificate of Income and Asset in the prescribed format as given in Annexure-I after carefully verifying the relevant documents to the persons' claim as belonging to EWS.
