NOTIFICATION

Whereas the Sikkim State Health Service Rules, 1993, has been framed vide Notification No. J (35)/22/Gen/Est., dated: 29.06.1993;

And whereas, the rules have two different Schedules viz. 'Schedule I' for Medical Doctors and 'Schedule IA' for Dental Wing;

And whereas, the inter-se-seniority for Medical Doctors falling under 'Schedule I' of the Service were notified only during the year, 2013, vide Notification No. 88/GEN/DOP, dated: 04.02.2013;

And whereas the Sikkim State Health Service Rules, 1993, have been further amended vide the Sikkim State Health Service (Amendment) Rules, 2018, notified vide Notification No.115/GEN/DOP, dated: 08.02.2018, wherein the 'Schedule I' appended to the Service has been divided into two parts viz. 'Schedule I' for 'General Duty and Public Health Wing' and 'Schedule-II' for 'Sikkim State Health Specialist Wing' The previous 'Schedule IA' for 'Dental Wing' has been renamed as 'Schedule III';

And whereas, as per Sikkim State Health Service (Amendment) Rules, 2018, the inter-se-seniority of Medical Doctors under Schedule I have been notified vide Notification No. 81/GEN/DOP, dated: 18.08.2018 according to their educational qualification;

And whereas, those existing doctors who have acquired Post Graduate Diploma or Post Graduate Degree in clinical, para-clinical, or pre-clinical subjects as prescribed in 'Schedule II A' after the commencement of the Sikkim State Health Service (Amendment) Rules, 2018, i.e. 08.02.2018, are not absorbed into Sikkim State Specialist Wing as initial constitution of the specialist wing on the basis of opinion of the Law Commission, Sikkim, through Law Department;

And whereas the State Government, on receipt of representation from Dr. Anjila Dorjee and Dr. Subash Tamang, who have done their Post Graduate Degree in subjects prescribed in Schedule II A of the Sikkim State Health Service (Amendment) Rules, 2018 but prior to fixation of inter-se-seniority vide Notification No. 81/GEN/DOP, dated: 18.08.2018, has decided to maintain their inter-se-seniority separately as Ex-cadre (Specialist), duly re-designating posts being held by them presently. The promotional avenue and service conditions of these Medical Doctors shall be at par with those



Specialists who were immediately below them in the inter-se-seniority as notified previously vide Notification No. 88/GEN/DOP, dated: 04.02 2013 as done in the case of those Medical Doctors whose Post Graduate Degree were not recognized by the Medical Council of India and whose inter-se-seniority have been fixed at Section 'C' of Notification No. 81/GEN/DOP, dated: 18.08.2018;

Now, therefore, the State Government, in partial modification of Notification No.81/GEN/DOP, dated: 18.08.2018 and after obtaining undertaking from the above mentioned Doctors is hereby pleased to order the following: -

- The inter-se-seniority of the under mentioned Doctors who have done their Post Graduate Degree in subjects prescribed in Schedule IIA after the commencement of Sikkim State Health Service (Amendment) Rules, 2018 but prior to fixation of inter-se-seniority vide Notification No. 81/GEN/DOP, dated: 18.08.2018, shall be maintained separately as Ex-cadre (Specialist) to be shown as "Section "D" of Notification No. 81/GEN/DOP, dated: 18.08.2018 duly re-designating the posts being held by them, as under:
 - (i) Dr. Angila Dorjee Bhutia, Sr. GDMO as Specialist (Ex-Cadre)
 - (ii) Dr. Subash Tamang, Specialist as Specialist (Ex-Cadre)
- The promotion of these Doctors shall be taken up along with those Specialists
 who were junior to them as per earlier inter-se-seniority fixed vide Notification
 No. 88/GEN/DOP, dated: 04.02.2013, duly upgrading the post.
- The name of the above two Doctors shall be deleted from the existing inter-seseniority under Schedule I & Schedule II of the Sikkim State Health Service respectively.
